CALL TO ORDER

Mr. Cesario called the meeting to order at 10:08 a.m.

MINUTES

Mr. Uba made a motion to approve the October meeting minutes. Ms. Kelley seconded the motion and it was carried.

DEPARTMENT OF PROFESSIONAL LICENSING REPORT (D.P.L. REPORT).

OLD BUSINESS

- The Board discussed Ms. Kelley serving as the KY Board representative for IC&RC's Special Committee. Ms. Kelley gave her report from the IC&RC conference held in Ottawa Canada in October.
- The Board discussed the Supervisory Training being held in Lexington in January. Ms. Kelley made a motion for the prior Board member and Chair, Geoffrey Wilson to instruct the training as was originally planned before his term ended. Mr. Noble seconded the motion and it was carried.
